# **Emergency appeal Turkey: Population Movement**



# Revised Emergency Appeal n° MDRTR003 GLIDE n° OT-2011-000025-TUR 28 May 2013

This Revised Emergency Appeal seeks a total of CHF 44,183,265 (an increase from CHF 32,311,220) in cash, kind, or services, and extends the timeframe of the operation by an additional four months (until 31 December 2013) so as to support the Turkish Red Crescent continuing to provide (TRC) in for 225,000 assistance up to beneficiaries accommodated in refugee camps in Turkey. Including the sum of CHF 8,341,902 received to date in multilateral contributions, the net Emergency Appeal request is CHF 35,841,363. A final report will be made available by the end March 2014.

**Appeal coverage:** some 18.8 per cent (provisional figure) against the revised total budget of CHF 44.1 million.

#### Appeal history:

- This emergency appeal had originally been launched on behalf of the TRC on 9 November 2012 for CHF 32,311,220 for a period of six months to assist 170,000 people.
- Operations Updates were published on 21 December 2012, 31 January 2013 and 9 May 2013.
- On 9 May 2013 the Appeal timeframe was extended until 31 August 2013 pending revision of the plan of action and the budget.
- This revised Emergency Appeal focuses on supporting the TRC's plan of action to continue providing support for up to 225,000 Syrian people who have found refuge in 17 camps on the territory of Turkey. The IFRC has been requested to assist with the mobilization of the resources to assist an additional 60,000 refugees that will be accommodated in five new refugee camps which are being established in Turkey.

**Summary**: The continued conflict and crisis in Syria is having a disproportionate impact on the humanitarian situation. UNHCR reports 1,557,134 people fleeing to the neighbouring countries. From this number, some 350,000 Syrian people are estimated to have taken shelter in Turkey. In the first half of May 2013 the average number of daily arrivals reached 8,000. According to UNHCR's projection, up to 1,000,000 Syrian citizens may require temporary protection in Turkey by the end of 2013.

Exceeding the original target of Syrian people mentioned in the Emergency Appeal of 9 November 2012, the Turkish Red Crescent (TRC) is actually assisting 194,968 Syrian citizens within the Turkish Government's

operation for supporting the temporarily protected Syrian citizens living in 17 camps in Turkey through the delivery of food and non-food items to the camps' residents.<sup>3</sup>

In the following one or two months, five new camps will be established by the Turkish Government, That will bring the number of camp residents to over 225,000. Through this appeal, the TRC will take the responsibility for the distribution of non-food items in the 22 camps in addition to other services.

This revised Emergency Appeal changes the focus from winterization-aimed activities to mid-term relief support to Syrian families that have been granted temporary protection in Turkey. The revised appeal will focus on nonfood items (NFI) distribution activities to complement the food-related activities funded by TRC and other partners in the form of e-cards in order to achieve a better coordination of the humanitarian agencies` efforts channelled through the Turkish Red Crescent. The non-food items include blankets, mattresses, bed sets, kitchen sets, stoves, heaters and electric fans for hot weather conditions.

The IFRC and the TRC would like to express their sincere thanks to the Red Cross / Red Crescent Societies and the Governments of Canada, Denmark, Estonia, Ireland, Japan, Kuwait, Monaco, Norway, South Korea Sweden, Switzerland, and the United States of America as well as to the European Commission Humanitarian Aid and Civil Protection (ECHO) for their support rendered in response to the IFRC's Emergency Appeal.

The TRC also conveys its gratitude to the Red Cross Societies of Bulgaria, Germany, Netherlands, Norway, Sweden, and the UK, as well as to the IOM, UNICEF, UNFPA, WFP and UNHCR for their support provided on a bilateral basis.

# The situation

The war in Syria continues to threaten the lives and well-being of millions of Syrians. UNHCR figures for the region depict 1,557,134 people fleeing to the neighbouring countries. Out of this figure around 850,000 people have moved during 2013.4 At 23 May 2013, some 350,991 Syrian people are estimated to be residing in Turkey.

The Turkish Disaster and Emergency Management Agency, AFAD, has recorded 194,968 Syrian citizens living in 17 camps in eight Turkish provinces under the temporary protection of the Government of Turkey. 5 The "temporarily protected person" status is granted by the Turkish Administration to those people who are officially registered and sheltered in Turkey from any disaster or conflict. This status grants the temporarily protected persons access to humanitarian support and basic services such as education and health. The following chart identifies the number of housing units and the average number of people per housing unit.

The Turkish Government prioritizes the allocation of housing facilities according to the people's needs. People living with disabilities or elderly people and families with many children are hosted in prefabricated units or container camps. The Turkish Government is also taking care of the Syrian people's safety and has increased passive security around the camps to prevent incidents from the outside.

In addition to the increase in the number of people registered by the Turkish Government, the UNHCR estimates 50 thousand people staying on the Syrian side of the Turkish-Syrian border and a number of other Syrians taking shelter with friends and families in need of humanitarian assistance. Thus, the Disaster and Emergency Management Agency of the Government of Turkey (AFAD) plans to open five additional protection camps by the end of June 2013. This includes a container camp in Kilis-Elbeyli with a capacity for over 3,000 families and a tent camp in Sanliurfa-Viransehir with a capacity for 3,000 families. A second container camp in Malatya will host some 2,000 families, and another tent camp in Mardin-Midyat will host an additional 2,000 families. All the container and tent camps, in total 22, will be able to accommodate around 220,000 people.

With little chances of a change in the escalation of the Syrian crisis in the near future, the humanitarian organizations' operations are turning towards a longer term support both in the camps and outside the camps. Until now, most of the relief operations in the country were funded by the Turkish Government with an overall cost of 1.5 billion USD.

# **Coordination and partnerships**

**Coordination with authorities:** From the side of the Turkish Authorities, the overall coordination of the relief activities for the Syrian population under temporary protection in Turkey is led by the Disaster and Emergency Management Agency (AFAD) and the Turkish Ministry of Foreign Affairs. The local AFAD bodies coordinate their activities with the respective Ministries of Health and Education of Turkey. The TRC continues to support AFAD in the supply of relief services including food and non-food relief item distribution and the supply of shelter items and materials.

**Inter-agency coordination:** TRC and AFAD work in close coordination and channel together the initiatives of various partners. TRC continues its cooperation with the UNHCR's Syria Regional Response Plan. UNHCR has donated funds for manufacturing 18,500 tents, and contributed to procure 2,260 hot-plate cookers, 3,760 mini-fridges and 3,760 shelves. These items are supplementary to the e-card food programme (a joint venture led by TRC and WFP) that is taking place in 14 camps for around 110,000 people.

#### **Red Cross / Red Crescent Movement Coordination:**

TRC is the leading Red Cross and Red Crescent Movement partner in the country and channels bilateral and multilateral Red Cross and Red Crescent contributions. TRC has reportedly received some CHF 4,862,799 of support through bilateral contributions. The British Red Cross's contribution to the TRC programme aims to provide some 25,000 people with tarpaulins, electric heaters, kitchen sets and mattresses. The German Red Cross Society's in-kind support enabled the TRC to carry out the distribution of 30,000 blankets and 10,000 hygiene kits. The bilateral contribution from the Netherlands Red Cross targets 100,000 people by distributing hot plate cookers, kitchen sets, blankets and hygiene parcels. The Norwegian Red Cross's support allowed the TRC to procure and distribute hot meals in Gaziantep-Karkamis. The Swedish Red Cross's in-kind contribution of 6,800 blankets targets Syrian people living in the Osmaniye–Cevdetiye camp. The support channelled through the IFRC appeal covers non-food items (NFI) – supplementary to other relief activities – and operational expenses, which are essential for the delivery of assistance to the vulnerable people.

# **Red Cross and Red Crescent action**

# **Achievements**

In line with its humanitarian mandate to address the needs of vulnerable population, the TRC's operation currently supports over 200,000 Syrians mainly through three types of relief activities: (1) Food support in camps, (2) Distribution of relief items in camps, and (3) Transfer of relief assistance on the border to people living outside Turkish territory. Given the escalation of the conflict in Syria and current population movement trends, the Turkish National Society may need to extend this support to some 500,000 people in the following months; this figure is half of the number forecast by UNHCR for Syrian people in Turkey for the end of 2013.

(1) Food support – the e-card programme: The TRC's e-card programme in camps has been developed based on the National Society's previous experience in cash assistance in urban areas. The current programme was initially launched as a joint venture with WFP for five camps in Killis and Hatay and has become a cost-effective alternative to the distribution of cooked meals. In addition to paper based e-vouchers, the e-card provides families living in camps with more freedom when choosing household items or food, as they can use the pre-charged e-card to purchase goods in agreed shops or outlets. It also allows TRC and funding partners to have better accountability for the delivery of assistance. The programme currently covers around

110,000 people in 14 camps, where shopping and cooking facilities have been made available. In some cases, supermarkets have opened stores in the camps, whereas in others, the camp administration provides transportation services to local markets for the Syrian people. TRC and WFP provide training and information on the use of the e-card to all families and run assistance services for helping families in cases of difficulties. The e-cards provide a sum of 80 TL (45 USD) to each person per month. This amount is enough to provide a basic daily diet of at least 2,100 kilocalories. The e-cards cannot be used to buy anything but food (excluding junk food) in the designated stores that are closely monitored by TRC and WFP. The e-card programme is supplemented by other relief distribution activities carried out by AFAD and the TRC. With the support of its partners, TRC distributes equipment allowing families to cook, such as cooking plates (electric stoves), kitchen sets, and shelves. Mini-fridges are also being procured and distributed for ensuring the safe storage of food. The camps' managing authority is in the process of upgrading the camps` infrastructure to match the increase of electricity power needs.

- Relief distribution in the camps: Since the beginning of the crisis, TRC has supported, from their own resources, the distribution of 44,575 tents, 25,791 tarpaulins, 569,793 blankets, 52,988 kitchen sets, 87,314 hygiene sets, 200,114 mattresses, 424 container showers, 103 general purpose containers, 203,027 diaper packs, 281,622 units of baby formula food, 165,649 units of bed linens, 2,141,250 units of clothes, 18,755 hot plate cookers and 16,284 heaters. In the case of more durable items such as tents, these figures represent a fixed stock and, when replaced due to usage, are not double-counted. In addition to this, the following items are under distribution or stocked in warehouses for repositioning: 3,031 tents, 530 tarpaulins, 29,114 blankets, 2,143 kitchen sets, 3,406 hygiene sets, 250 mattresses, 17 container showers, 5,891 diaper packs, 16,137 units of baby formula food, 615 units of bed linens, 75,867 units of clothes, 10,896 hot plate cookers, and 4,479 heaters.
- (3) Transfer of relief assistance to Syrian people living outside the Turkish territory: The TRC does not carry out cross-border actions. However, guided by the Red Cross and Red Crescent Movement's principles, TRC considers it important that people in need on the Turkey-Syria border should have access to humanitarian assistance. Using TRC resources, these activities are carried out in coordination with Syrian communities and local associations, to whom relief aid is transferred at border points within the Turkish territory, while the Syrian partner organizations carry out the distribution of the transferred relief items within Syria.

# The revised operation

This revised Emergency Appeal broadens the scope from winterization-aimed activities to mid-term support for Syrian families temporarily protected in Turkey. It will also cover an increased number of families so as to support half of the people TRC expects to reach with basic relief activities during the period June – December 2013. The proposed revision emphasizes continuous TRC capacity building activities and support for operational costs in benefit of the overall operation.

The revised Emergency Appeal aims to support TRC in moving from hot meals distribution to an e-card food assistance approach through the procurement and distribution of essential household items in the camps that the food e-card program will be extended to. Provided that funding is available, support to the TRC will be extended to the procurement and distribution of essential household materials in five new refugee camps which will be established by the Turkish Authorities before the end of June 2013. The number of new beneficiaries in these camps is estimated at around 50,000 people.

The revised operation will include the monthly distribution of hygiene kits to 200,000 beneficiaries in all 22 camps where the TRC has full responsibility for the provision of food and non-food items. In addition, a contingency stock will be created for 5,000 families in the anticipation of an increased number of Syrian refugees arriving in Turkey.

The proposed extension of this component was requested by the TRC and aims at the mid-term continuation of on-going activities in all camps supported by TRC and at the extension of these activities onto the camps that will be opened soon to host the Syrian population sheltering in Turkey. The activities have been agreed with TRC in order to avoid the duplication of efforts and improve fundraising with other humanitarian organizations, so that activities should supplement each other. The table underneath shows the list of identified needs. In the fourteen camps where TRC carries out food e-card activities in partnership with WFP, most cooking related items are being covered with the support of UNHCR and Red Cross and Red Crescent Movement partners. The Emergency Appeal is to cover the on-going purchase and distribution of kitchen sets, fridges, hot cooking plates and shelves for 55,000 people living in the camps where the TRC food e-card programme will be organized. The same support for cooking hardware needed for using the food e-card will be provided to the new camps, and the program will also include beds, mattresses, pillows and bed linen as well as heaters as part of the standard items assigned for each tent. The operation's budget aims to ensure the hygiene kit supply for all camps during the following months, and it will also contribute to the distribution of electric fans for alleviating the hot weather conditions during the summer season.

In addition to providing support for the population living both in the currently existing and the soon-to-open camps, the operation sets up a contingency stocking plan for 25,000 people in case the humanitarian situation further deteriorates. The list of non-food items for accommodating up to 5,000 families includes the following:

Tents under this component of the appeal will be locally manufactured according to TRC requirements and field tests that match international standards. The local procurement of NFIs by the Turkish National Society will follow TRC procedures, endorsed by IFRC. The following will be procured under this component for transitional shelter provision:

- Prefabricated WC containers (as per the camp plan for 10,000 people);
- Prefabricated bathroom containers (as per the camp plan for 10,000 people);
- Multipurpose tents 210 square meters;
- Multipurpose tents 105 square meters;
- Multipurpose tent 63 square meters.

The multipurpose tents will be used in the camps for warehousing and social activities such as schooling, activity halls, meetings and briefings, psychosocial activities etc. The prefabricated sanitation containers (showers and WC) will contribute to safe water supply and sanitation services in the camps. Container use assignment, energy supply and waste management are administered by the AFAD's local representatives.

The above-mentioned activities aim to support TRC structures to cope with the magnitude of the crisis while rendering technical advice and improving knowledge on disaster management and security, and maintenance of equipment necessary for daily operations. TRC is currently translating the SPHERE Handbook and the IFRC "Stay Safe" tools into Turkish and is also contributing to the translation of the IFRC Learning Platform website, and the members of the TRC International Programmes Department are now receiving on-line training.

#### **Capacity of the Turkish Red Crescent Society**

The Turkish Red Crescent Society (TRC) was established in 1868 and is a founding member of the International Federation of Red Cross and Red Crescent Societies. It serves the Turkish people's communities and vulnerable people living overseas with its 3,568 employees and 760 branches. TRC has nine Regional and 23 Local Disaster Management and Logistics Centres, and is capable of providing emergency shelter and food for 300,000 people in case of any type of emergency or disaster.

Empowered and supported by the community, TRC carries out large scale humanitarian activities in times of disasters. It has been engaged in offering social support programmes, organising youth, delivering health services, in collecting blood and delivering blood products.

TRC has been involved in providing humanitarian assistance to the Syrian people under temporary protection since the start of the operation: it has deployed 120 staff to the 17 camp sites. It has one main field coordination office, seven field sub-offices, and two main warehouses to ensure the smooth running of the operation in benefit of the Syrian people.

#### Capacity of the IFRC

The IFRC Europe Zone Disaster Management team provides technical support to TRC in the areas of planning, external communications, reporting, capacity building and resource mobilization. An embedded Federation Reporting and Communications Delegate is currently supporting the National Society in those activities.

The IFRC Europe Zone Office has been maintaining regular contacts with their colleagues in the IFRC Middle East and North Africa (MENA) Zone Office and the IFRC Secretariat in Geneva to ensure a timely exchange of relevant information, the coordination of important actions and the use of the global disaster response tools.

# Monitoring and evaluation

TRC carries out the monitoring and evaluation of its activities and shares updated information with the IFRC Secretariat for publishing regular operations updates and other reports. The IFRC Reporting and Communications Delegate supports the TRC's narrative and financial reporting for internationally funded activities, both the bilateral and the multilaterally funded ones.

The IFRC Delegate, assigned to TRC, will continue to perform the following responsibilities during the next six months:

- Coordination and information-sharing with Movement partners and other humanitarian agencies through bi-weekly Fact Sheets on operational progress.
- Introducing a standardized reporting template for donor reporting.
- Establishing close working contacts with all humanitarian actors operating in Turkey.

The overall official information for the relief operation in Turkey is provided by the AFAD and the camps' administration. The National Society wishes to inform all stakeholders that field visits by foreigners to the camps are restricted in line with government policies. However, TRC and some of its partners (UNHCR and WFP) will continue carrying out visits to the camps in order to support the implementation of the operations and monitoring. In coordination with the camp managers, TRC has been sharing demographic data of people living in the camps.

In terms of logistics, TRC shares the status of procurement and distribution of non-food items through information sheets sent to the supporting partners.

At the end of the operation, a meeting will be organized for sharing and reviewing the "lessons learned" during the implementation of the activities. This meeting can also look at innovations by TRC that may be shared with other National Societies which are interested in such solutions, such as shelter materials and the food e-cards project organized in the tent/container camps.

#### Communications – advocacy and public information

The TRC's Public Relations and Media Department shares news, photos and videos through their institutional websites at <a href="http://www.kizilay.org.tr/">http://www.kizilay.org.tr/</a> and <a href="https://www.facebook.com/TurkKizilayi.org">https://www.facebook.com/TurkKizilayi.org</a>. Also, the Public Relations and Media Department carries out and supports joint activities with UN partners.

During the previous months, the IFRC Europe Zone Office Communications Department and the TRC's Public Relations and Media Department strengthened their links in order to maintain a regular flow of information among stakeholders. Humanitarian activities carried out by the Turkish National Society are shared with the public through the TRC's institutional website, and the information is now available at the IFRC blog. Also media releases can be found on the IFRC Media site.

The IFRC Secretariat and the Turkish Red Crescent are aiming at the development of a harmonized communication strategy which will target key stakeholders including the media, National Societies, and prospective donors.
