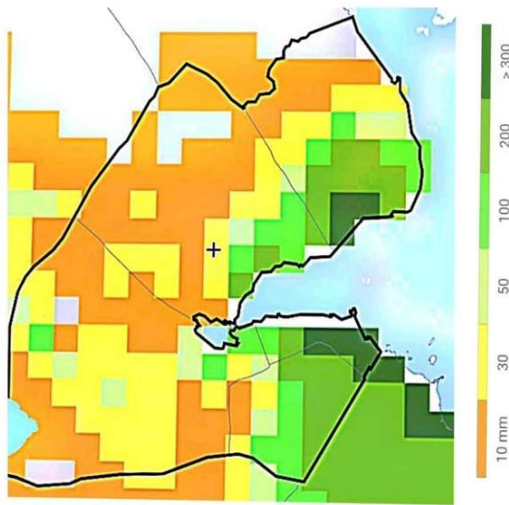

Durant la semaine du 14 au 21 Novembre 2023 des précipitations faibles à modérées sont prévues sur les régions côtières et le Sud-Est de la République de Djibouti.



Activation Overview

Djibouti Red Crescent National Society has activated its Simplified Early Action Protocol for Flood.

Djibouti's seasonal forecast for October-December shows a rainfall impact related to the El Nino event.

ICPAC and Djibouti Met have released the weekly forecast that indicates a potential rainfall in the coastal zones such as Djibouti, Tadjourah, Obock, Arta and a few areas of Dikhil will be affected.

National Society has been monitoring the threshold and for the period of 14-21 November 2023 the trigger which is total rainfall of 50mm and above in Djibouti and its suburbs in the next 7 days and ICPAC) East Africa hazard watch, forecast shows a "heavy rainfall" alert for the next 7 days for Djibouti city and its suburb is reached.


DRCS will target 2,500 people from households living in the risk-prone area at risk of displacement, with low-income, females or child-headed households, large households with 3 or more children, households with children under 5 years, and households with elderly members.




Anticipatory actions will be taken place among the Balbala living community within 7 days to raise awareness of the predicted meteorological event by reaching the community with early warning messages

and promoting hygiene especially for water stagnation-related health negative issues, strengthening their capacity in risk reduction by distributing and replacing their roofing materials. A large public will be sensitized through the National media house.
